Rates are \$16 per night, per dog. Special rate of \$400 per month for long-term stays. All drop-offs and pick-ups by appointment only, between 9AM and 8PM eastern time. Late fee of \$25 or more may be applied if Owner is more than 15 minutes late for appointment.

This is a contract between Trish James d/b/a Just Like Home Dog Boarding (hereinafter called "Kennel") and the pet owner whose name appears on the contract (hereinafter called "Owner"). The terms of this agreement shall apply to any and all dates the pet is boarded at Kennel. Owner agrees to pay all costs and charges for boarding and special services requested. All charges incurred by Owner shall be payable upon pick-up of pet. Owner further agrees that the pet shall not leave the kennel until all charges are paid to kennel by Owner unless other arrangements are made. Cash, check, credit/debit card payments are accepted. The Kennel shall have and is hereby granted a lien on the pet for any and all unpaid charges resulting from boarding pet at the kennel. If Owner neglects to pick up pet within 10 days of checkout date, Kennel may consider the pet abandoned and may dispose of pet for any and all unpaid charges at private or public sale in the sole discretion of the Kennel, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of board or other charges delinquent plus costs of sale, then Owner shall be liable to Kennel for the difference. All monies realized by Kennel at such sale over and above the charges due and costs of sale shall be paid by Kennel to Owner. Owner understands that Kennel offers group play, and Owner accepts any risks involved with such action. Owner specifically waives all statutory or legal rights to the contrary. Kennel shall exercise reasonable care for the pet delivered by the Owner to kennel for boarding. Owner will not hold Kennel liable for injury, escape or death of pet while in the care of the Kennel. It is expressly agreed by Owner and Kennel that Kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200 per animal boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the Kennel. Owner represents that pet has no history of aggression toward other animals. Owner specifically represents that he or she is the owner of the pet, free and clear of all liens and encumbrances. Owner specifically represents to Kennel that the pet has not been exposed to rabies, distemper, or parvo within 30 days prior to boarding. If pet becomes ill/injured or if the state of the animal's health otherwise requires professional attention, the Kennel in its sole discretion may engage the services of a veterinarian or administer medication or give other requisite attention to the animal and the expenses thereof shall be paid by the Owner. By signing this contract and leaving the pet with Kennel, Owner certifies to the accuracy of all information about the pet listed on this contract. This contract contains the entire agreement between the parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives, and assigns of the Owner and the Kennel. Any controversy or claim arising out of or relating to this contract or the breach thereof or as the result of any claim or controversy involving the alleged negligence by any party to this contract shall be settled in accordance with the laws within the jurisdiction of Russell County, Alabama. The failure of Kennel to enforce any provision of this contract shall not constitute a waiver of the Kennel's right to enforce any other provision of this contract.
